Terms and Conditions

Parties.
The company means G. Seller Independent Funeral Directors and Expert Memorial Masons. Our addresses are:

Our company registration number is 827623.
The client is the person responsible for arranging and paying the charges of the funeral. Also the client's name and signature is shown on this document.

Terms
The contract shall come into existence only when it has been signed by the client.

Payment/Price.
Any estimate is an indication of charges presently known and will be subject to alterations if:

- 3rd Party Charges cannot be determined at the time of making funeral arrangements
- Components/variations are either added or removed from the arrangements, prior to the funeral taking place.

For an **Attended** or **Unattended** services all fees are to be paid up front at least 3 working days prior to the funeral taking place.

For a **Barsby** or **Bespoke** service either:

- an invoice will be raised in its entirety based on estimated fees prior to the funeral taking place (based on the understanding G. Seller will refund or invoice for any difference in fees)
- or the 3rd Party Charges are to be paid to the Company at least 3 working days prior to the funeral taking place. The company shall reserve the right to cancel the contract with the client if payment is not forthcoming. The company shall render the final invoice approximately 7 days from the date of invoice. Payment is anticipated in full 14 days from the date of invoice.

In the event that payment is not made by the due date, the company reserves the right to charge interest of 1.5% above the base rate from the due date until the actual date of payment. Should the company need to pass on any outstanding amounts to a collection agency, the client shall be liable for all additional costs.

General.
The order is personal to the client and the client shall not assign or transfer to any person their rights or obligations under this contract. The client will acknowledge and confirm that they have the authority to enter into this agreement with the company. The client is personally responsible for the payment of the invoices for all services rendered. If you are dissatisfied with any aspect of our service, please contact the company within 14 days of the

service provided. If we are unable to resolve the complaint the client may write to the National Association of Funeral Directors, 618 Warwick Road, Solihull, West Midlands B91 1AA.

Memorials.
Memorials are removed to allow a full interment to take place. Your memorial will be safely stored for approx. 12 months from the date of interment.

A charge on the estimate has been offset for the removal, storage and re-fix to current safety standards. In the interim we will submit a written quotation to add an additional inscription to the memorial together with any renovation work that we recommend before we re-fix your memorial onto the grave.

Please be advised that:

- We will try to contact the client twice
- If we do not receive a response to the quotation without good reason - approximately 12 months (weather permitting) after the interment we will re-fix the memorial back upon the grave to current NAMM safety standards.
- It is the prerogative of the client if you would like to appoint your own Memorial Mason to remove the memorial from the grave before the interment takes place. If this is the intention of the client we would ask that our office is informed at least 3 working days prior to the funeral taking place.
